EXECUTIVE SUMMARY

Executive Summary

The fourth quarter and final report for 2016 provides a succinct update of MCAPP's third quarter report (submitted September 2016), which detailed major accomplishments over the last three years (2013-2016), and challenges MCAPP faces in 2017.

Annual Progress

Throughout 2016 MCAPP demonstrated steady, continuing progress in *preventing childhood* sexual violence via four change objectives:

- 1) **Primary prevention education (PPE)** provided to children, youth, families and communities to prevent & reduce risk of childhood sexual violence;
- 2) Establishing a *culture of safety and wellbeing* utilizing community coalitions & networks;
- 3) Strengthening appropriate, trauma-informed service response with community PPE training/events:
- 4) Implementing program evaluation research with goals of improved services, advocacy & sustainability.

MCAPP's 2016 overall progress is visually represented in the Progress Summary infographic (see next page). Program objectives were qualitatively and quantitatively scored using a progress rubric (see Attachment A). Each objective may be given a potential maximum of 25 points. Objective 1, PPE received a score of 20 points; Objective 2, 15 points; Objective 3, 17 points; and Objective 4, 18 points. The total of all objectives together provide an overall score of 70, which qualitatively translates to "achieving objectives".


MCAPP's consistent provision of PPE, coalition-building, professional development training and program evaluation have contributed to a climate of safety, which in turn led to increased reporting of child sexual violence (Child & Family Services, 2016). MCAPP continues to increase its reach, but has a great deal more to accomplish, especially in the areas of developing a culture of safety, supporting competent community response to sexual violence, and sustaining prevention practices.

PROGRESS, SUSTAINABILITY AND CHALLENGES

Progress, Sustainability and Challenges

OBJECTIVE 1: PRIMARY PREVENTION OF SEXUAL VIOLENCE

Primary Prevention Education Activities

During the 4th quarter, high school and middle student participation in MCAPP's prevention education increased by 55% in comparison to the 3rd quarter (417 to 648; see Table 1). The participation rates increased 89% from 342 in the first quarter, to 648 in the 4th quarter (see infographic page 2).

OBJECTIVE 2: DEVELOPING A CULTURE OF SAFETY

Coalition-Building

Community participation in activities related to developing a culture of safety (coalition building activities) increased by 91%, from 90 in the 3^{rd} quarter to 172 in the 4^{th} quarter. The annual increase was 61% (from 107 in the 1^{st} quarter to 172 in the 4^{th} quarter).

MCAPP collaborated with nine community organizations during this quarter. These included: Ho`okikaika, IN PEACE, Community Action Team, Tutu and Me, Maui Food Bank, Kulana Oiwi Halau, Kanoa Senior Services, Alu Like and Workforce Development.

Moloka'i Kupuna Legacy Project

The Molokai Kupuna Legacy video is in the final phase of editing, music synchronization and credits. It will be ready for a premier viewing in Moloka'i at the end of January or early February.

OBJECTIVE 3: SUPPORTING COMMUNITY PRIMARY PREVENTION RESPONSE

Education and Training

This quarter, MCAPP staff participated in six professional trainings in the areas of: Ho`oikaika protective factors conference; a Community Action Team (CAT) Leader Conference on engaging men in the preventing sexual violence; CAT training on child abuse prevention strategies; Chaminade University, non-profit development seminar; Brian Ezuka's non-profit education for board members; and the Sexual Assault Prevention Curriculum Workshop sponsored by the Washington Coalition of Sexual Assault Programs and National Sexual Violence Resource Center (NSVRC).

PROGRESS, SUSTAINABILITY AND CHALLENGES

OBJECTIVE 4: PROGRAM EVALUATION AND SUSTAINABILITY

Progress Toward 501c3 Status

The completed 501(c)3 application for recognition of exemption was submitted to the Internal Revenue Service in early December 2016. Applications may take five to seven months to process. In the meantime, Brian Ezuka, Esq. has advised us that we are not able to solicit donations until we receive official federal non-profit status. Likewise, grant applications will also need to be submitted to entities that do not require non-profit status.

Funding and Grants

On October 24, 2016, MCAPP's application for RFP No. HT-560-CF-008, Sexual Violence Prevention Services, (a total of \$200,000, over a four-year period) to Hawaii Department of Health submitted September, 2016 was not selected for funding. Our application received a score of 62 out of 100 (see accompanying PDF document, Statement of Findings and evaluation worksheet).

Strategic Planning & Timeline

MCAPP staff will conduct their annual strategic planning meeting on January 17-18, 2017. A major focus of the agenda will be the MCAPP Timeline to Independent 501c3 Status (Attachment B), a tentative forecast of events and activities geared toward independent status January, 2018 (a detailed discussion was provided in third quarter report to the Consuelo Board).




